The undersigned hereby authorizes SICBA, or its assigns, to initiate and make debit entries to the account indicated. Withdrawals will be made upon approval of membership; then on the 5th of each month for payment to Payee of all amounts owed by the undersigned pursuant to the contracts referenced above by the undersigned to Payee as set forth in the annual dues described above. An authorized signor on the Company's checking/savings/credit card account indicated above must execute this Authorization Agreement. The agreement binds the Payer to one full year of membership dues paid in installments. In the event funds are not available in the bank account noted above on the day payment is due, SICBA or its assigns will attempt to draft again within three (3) business days. A fee may be assessed to the account for each transaction if funds are not available, For my convenience, membership renewal is automatic each year. If Payer wishes to discontinue monthly payment option, outstanding membership fees are due in full upon notification.
